Municipal Minutes

July 9, 2019 Regular Meeting: Councillors Mitchell, Campbell, Paterson, Bollman, Hales, Bromley and Reeve Farley attended. Proposed draft fire response areas were approved with Rapid City Fire Department and Riverdale Fire Department pending a meeting with Brandon Fire and Emergency Services to discuss boundary changes. Addition of an additional phone line into the office was approved. Financial Statement for the month ended June 30, 2019 was accepted and filed. 2nd and 3rd readings to BL 1615 (RFNow Agmt) were given and passed. Council revised speed limits following comments from the community, and revised maps will be reposted for further comments. 2nd reading of BL 1616 (Establish Speed Limits) was given. 1st reading to BL No. 1617 (Procedural) was Elton Planning Transition given. Committee was authorized to award the contract for Recruitment Services for required staff for the new joint planning

district in conjunction with RM of Cornwallis. Quotes for Ward 4 work awarded Bluestar was to Construction for culvert installation and ditch cleanout. Policy 6-2012 for Beaver Dam Removal responsibility and costs was approved as amended. Policy No. 72-2019 for erection of signage in settlement centres was approved. Staff overtime to June 2019 was approved. Authorization to Performance attend Appraisal Seminar was given to Councillors Mitchell and CAO Steele. Authorization to reimburse Parley for dust control application was given due to it being applied at the mailboxes on PTH #10 and PTH #25. Accounts were approved in the amount of \$126,765.28 as per list of accounts presented to Council. Meeting adjourned to meet again on Tuesday, August 13, 2019 at 9:00 am or at the call of the Reeve.

Fire Pit Policy (Villages)

Policy No. 34-2013

POLICY DESCRIPTON: Be it resolved that Council of the RM of Elton adopt the following policy for fire pits within the villages of Forrest, Douglas and Justice located in the Rural Municipality of Elton. All village fire pits must:

- Be at least 3 metres (10 feet) from any building, property lines or combustible materials;
- Have an overall pit depth that does not exceed 36 cms (14 inches) and a pit opening that does not exceed 61 cms (24 inches) inside diameter;
- Have a spark arrestor mesh screen with a grid no larger than 1.25 cm (1/2 inch);
- Have enclosed sides made from brick, concrete blocks or heavygauge metal or other noncombustible materials acceptable to Council or their designate;
- Not be used to burn prohibited debris.

All landowners and/or renters using fire pits are reminded to be "Good Neighbours" and ensure that any smoke from their fire pit is not heading into their neighbour's yard which may be deemed a nuisance.

Please refer also to Burning By-law No. 1455 for additional provisions relating to burning. The Burning By-law No. 1455 provisions supercede policy where any discrepancies may exist.
